Reservations are available on a first-come, first-served basis and must be paid at the time of reservation. The fee for Active-duty and Retired Military personnel is \$60.00 per day. The fee for DoD civilians and Government Contractors is \$145.00 per day. Carr Point Recreation Area is available for reservations seven days a week from 12 - 8 p.m. All reservations and questions should be directed to the MWR Concierge Office (401) 841-2094.

Rules and Regulations:

- In case of sudden inclement weather you must follow Navy Safety Precautions and vacate the fields as soon as you are aware of the weather situation or if notified by MWR Staff.
Patrons are responsible for picking up all garbage and debris around picnic area.
Patrons are responsible for cleaning/wiping down of all tables and benches.
* Failure to comply with these rules will result in a \$50 cleaning fee and will be payable by the sponsor.
Pets are allowed only if leashed. Please clean up after pets.
The consumption of beer/wine/spirits is authorized in the picnic area during scheduled parties. However, consumption of alcohol may be limited, or even prohibited, at the discretion of the Naval Station Newport Commanding Officer.
Individuals under 21 years old shall not be permitted to consume or dispense alcoholic beverages.
Overnight storage of alcoholic beverages is not permitted.

- To prevent a broken glass safety hazard, no glass bottle containers of any type are permitted.
Vehicles are not permitted in picnic areas. All parking must be in designated marked parking areas only.
* Arrangements may be made with the reservation staff for loading/unloading of supplies for your party.
Patron swimming and bathing in the water is prohibited.
Patrons are responsible for securing all required permits, if needed.
Patrons must maintain good order and discipline at all times.
Groups requesting early entrance for set up, must make prior arrangements with the Concierge Office.
Cancellation Policy: A full refund will be issued if cancellation is requested at least 48 hours in advance. Unfortunately, no refunds can be made less than 48 hours before scheduled time.
